EXHIBITOR REGISTRATION

Exhibitor registration launches Wednesday, July 24th. Review the Exhibitor FAQ online here to prepare.

All attendees who will require access to the exhibit hall during exhibitor only hours <u>MUST</u> have an exhibitor badge type. Exhibitor only hours include:

- Set-up
- Dismantle
- One and a half (1.5) hours before opening each day
- Two (2) hours after closing each day
- Booth staff during exhibit hall open hours

Attendees without an exhibitor badge type will only be admitted during open hours, 9:30 a.m. - 2:30 p.m., Thursday – Saturday.

New for 2024!

- Exhibitor administrators will be able to send a registration link to their delegates so that they may create their own registration profile. This eliminates the need to collect personal information from your attendees.
- Exhibitor administrators will also be able to move attendees who have registered themselves into your exhibitor portal to assign them an exhibitor badge.

DEADLINE: July 12, 2024


